

## Town of Milladore September 12, 2021 Meeting MINUTES

**Board Members present:** Hank Nigh, Leon Kundinger, Chris Hollar, and Ken Manlick, Connie Milz absent.

**Assembly members present:** Ron Koziczkowski, Bob Ashbeck, Cheryl Nigh, Connie Smith, and Paul Ruesch

The September 12 Town of Milladore Supervisors meeting was called to order at 6:30pm by Leon Kundinger acting chair, with the Pledge of Allegiance.

Additions to agenda: Reclaiming ditches from property owners, Levy increase, Stevens Point School district recall election in January, Dot Gov email address request from Wisconsin Elections Commission, Redistricting in Wood County, Bicycle and Pedestrian Plan for Wood County.

The August 1 secretary report was read, Hank moved to approve, Leon seconded, motion carried.

Treasurer's report was read with August correction followed by the September report Leon moved to approve, Hank seconded, motion carried.

### Old Business

ATV concerns noted, failure to stop at stop signs, loud around 9pm, however, curfew extends until 10pm. Review probationary period for October agenda.

Ron presented End Loader Research of three brands CAT, John Deere, and Case new and used options. Price range between \$250,000 and \$187,000, follow up needed on 30% discount for Towns.

The courtesy post card to be sent from planning and zoning (Connie working on) was modified to include a reminder that 33 feet from the center of the road is the town's property and to remind property owners to keep the ditches free and clear of debris and crops. In addition to the removal of leaning trees, and snow removal not into the road ways.

### New Business

Clerk shared received information from Rural Mutual Insurance, and Reports from the Department of Revenue.

Managed Forest Land Application for D. Furo parcel was forwarded to town assessor to respond to state with any concerns.

Hank presented the 2022 Recycling Center Funding request of \$10,300. Recommendation to increase budget line item in November to accommodate overages of increased recycling and solid waste costs.

Fire Number/Address sign for property owners to pay for replacement sign was tabled to October meeting. Recommending property owner pay for new and replacement sign.

Certified Survey Maps were reviewed for Barbara Yanke (Section 11, T23N R2E) and Michelle Dillinger (Section 5, T25N R5E) were motioned for approval by Leon, seconded by Hank, motion carried.

## **Standing Agenda Items**

Bob Ashbeck reported that the request for funds for two road projects had cleared his committee and were being reviewed by the economic development committee.

Connie will be joining the Town Road Improvement Program committee with WTA. She was trained in the PACER program that rates town roads. Connie is developing an Emergency Contact list for weather emergencies, so people know who to call in triage order, four names were added to the list.

**Recycling Center** – Recycling Center had a good White Good Day filling two dumpsters.

## **Additions to agenda**

Clerk shared that the Stevens Point School district is currently gathering 7000 signatures to recall half of the school board. The election would take place in January if signatures are submitted on time.

The Wisconsin Elections commissions is requesting and by 2022 will be requiring all Clerks to secure a Dot Gov email address to prevent fraudulent communication regarding elections. This would require the Town of Milladore to pay for the .gov domain name.

Wood County is currently going through redistricting which is being spearheaded by the Wood County Clerk we believe there will be no changes to the Town of Milladore.

The Bicycle and Pedestrian Plan for Wood County is seeking feedback, you can share your suggestions on their website.

If the town of Milladore is planning to increase their Levy this needs to be discussed before the November 7 budget meeting at a special meeting. This meeting requires a 15-day notice for a resolution increasing the levy to be passed.

Leon moved to pay bills, Hank seconded, motion carried.

Hank moved to adjourn meeting, Leon seconded, motion carried.

Next meeting is set for October 3 at 6:30pm at the Town of Milladore.
