

## Town of Milladore December 5, 2021 Meeting MINUTES

**Board Members present:** Connie Milz, Hank Nigh, Leon Kunding, and Chris Hollar, Ken Manlick was absent.

**Assembly members present:** Ron Koziczowski, Bob Ashbeck, Ray Milz, and Nick Nigh

The December 5 Town of Milladore Supervisors meeting was called to order at 6:30pm by Connie Milz with the Pledge of Allegiance.

There were no additions to agenda.

The November 7 secretary report was read, Leon moved to approve, Hank seconded, motion carried.

Treasurer's report was read Leon moved to approve with corrections, Hank seconded, motion carried.

### Old Business

Discussion of 5-year plan revolved around survey may of current Town Hall property with homeowner of corner lot for access to Mayflower Road, purchase of property behind shop to place a well, and getting the area surveyed. Will place conversation about purchase of land on Annual Meeting agenda.

In addition, discussed the corner of West Street and Trestik Road drainage challenge. Leon moved that the Town of Milladore would pay up to \$1000 regarding dredging of the culvert at the corner of West Street and Trestik Road in conjunction with the Village of Milladore's challenge of appropriate drainage of water wells in that space, Hank seconded, motion carried.

Emergency Management Plan review was tabled until January.

Chair presented poll worker list for 2022-2023 election year, the list includes: Tracey Peplinski, Paul Haffenbredl, Karen Kuehnhold, Ron Koziczowski, Jill Altmann, Leslieanne Ruesch, Sally Furo, Mae Linzmeier, and Joel Kuehnhold. Connie moved to approve, Leon seconded, motion carried.

Tax letter was reviewed with suggested changes before sending with taxes.

### New Business

Nick Nigh from Sherry Fire Department presented report to Town Supervisors from the Sherry Fire Department, with a reminder that the liability insurance update will happen in February and a new certificate of liability insurance will be issued at that time. Auburndale Fire Department was unable to attend.

The 2022 Ambulance Service Contract with the City of Marshfield was reviewed with the 5% increase with half paid out in February and the remainder in August 2022 for a total of \$24,226.

The board reviewed the Shoreland Zoning Permit Application for the Pipeline maintenance for Flint Hill Resources Pine Bend, LLC.

The South Wood County Human Society Contract was reviewed by the supervisors with the recommendation that the municipal cost of an animal pick up could be passed along to the Town of Milladore citizens in the future. The SWCHS is moving to quarterly billing if their service is utilized.

The Wisconsin Uniform Dwelling Code Ordinance and Destruction of Obsolete Records were reviewed, updated, and signed. The Resolutions were tabled to the January Meeting.

### **Standing Agenda Items**

Bob Ashbeck further reported the reason for the concern of increased nitrates in well water in Grand Rapids area is the Central Sands area would like all of Wood County to cover the cost of cleanup.

Supervisors revisited the information Hank received from Waushara County that sprays an inhibitor to decrease growth of ditch weeds & brush to about 8". Requested to have speaker come and share more information about this treatment and possible use this April (2022).

Bob requested input on purchasing solid waste refuse bags and the number he should purchase now, with the money being recouped as we move through 2022.

The Conservation, Education, and Economic Development Committee (CEED) of Wood County awarded two grants of \$2,885.00 and \$4,129.45 to the Town of Milladore for the Blenker Road from Hwy 10 to Trestik Drive and Trestik Drive from Blenker Road to Mayflower Road projects.

Funding was also received through LRIP (Local Road Improvement Project) for Blueberry Road.

Connie still working to secure FEMA money from 2017 weather related damages.

Hank moved to pay bills, Leon seconded, motion carried.

Leon moved to adjourn meeting, Hank seconded, motion carried.

Next meeting is set for January 2 at 6:30pm.
